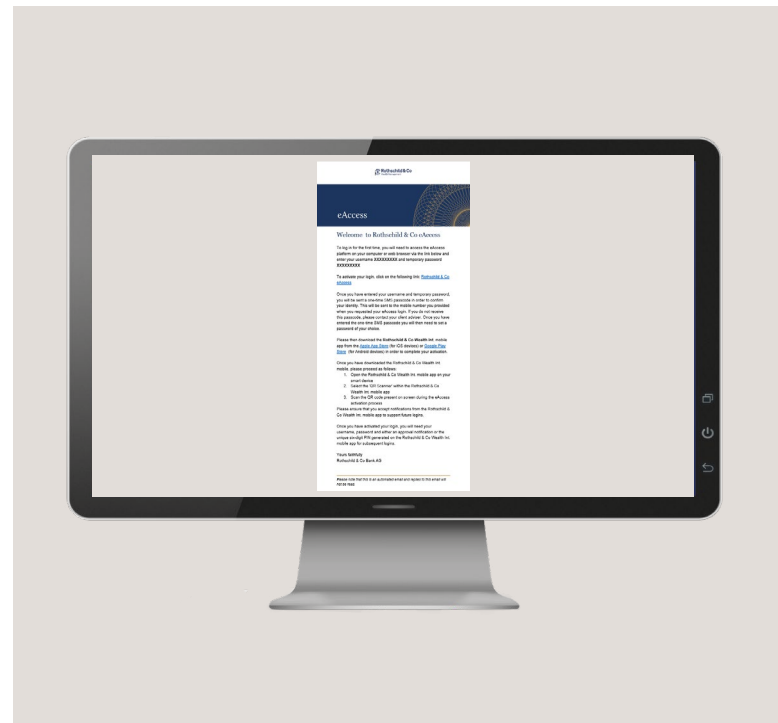

# Before you activate eAccess: What you need

To activate eAccess you will need four things:

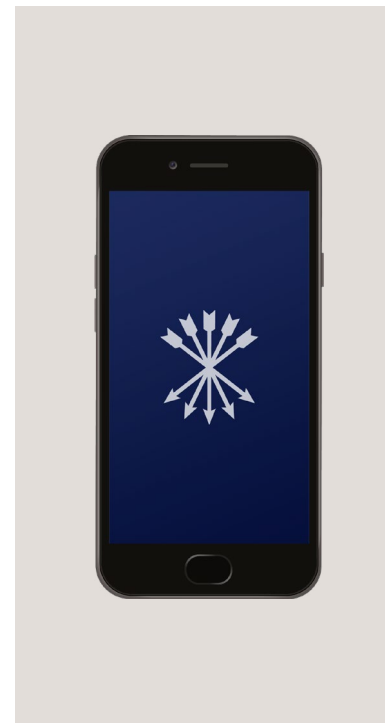
**Item 1:**

Your activation email '**Welcome to Rothschild & Co eAccess**' with your username and temporary password. (If you have a letter with your login credentials, please have both letters at hand).



**Item 2:**

A smart device (such as a mobile phone or tablet) with biometrics enabled.



**Item 3:**

A personal computer (PC), iPad or Tablet.



**Item 4:**

Internet access for both your smart device and PC.

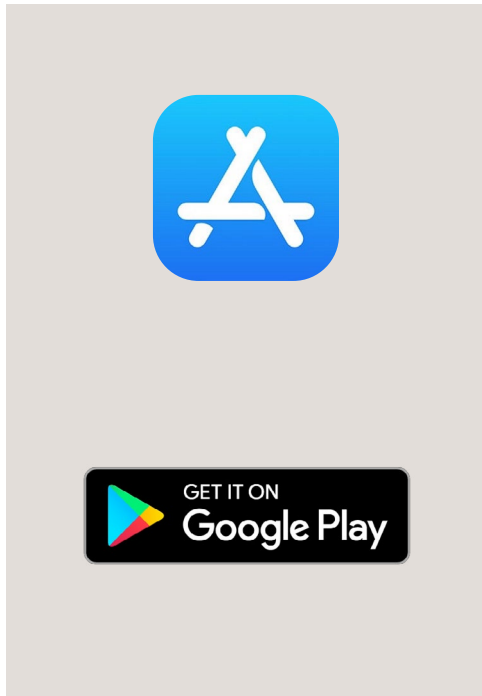
# Step 1: Downloading the Airlock 2FA App

## Downloading the Airlock 2FA app using your smart device

In order to activate eAccess and log in, you will need to download the Airlock 2FA app on your smart device. Airlock 2FA is Rothschild and Co's chosen partner to provide secure authentication for our eAccess platform. This can be found on the Apple App Store (iOS devices) or on the Google Play Store (Android devices).

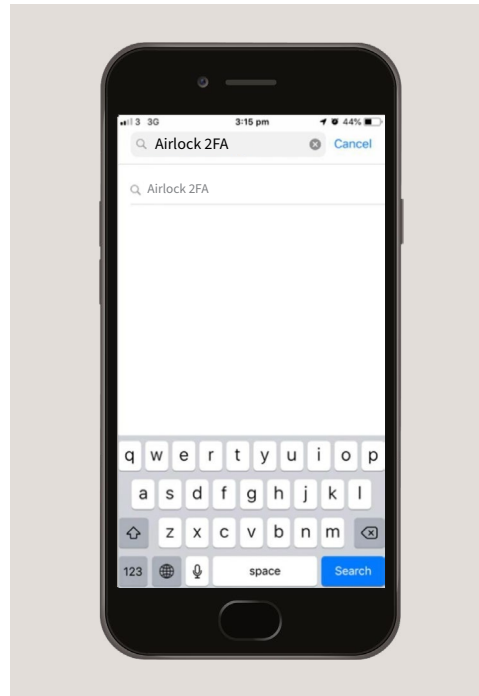
### Step 1a:

Open the App Store or Google Play Store on your smart device by clicking on one of the icons as shown below.



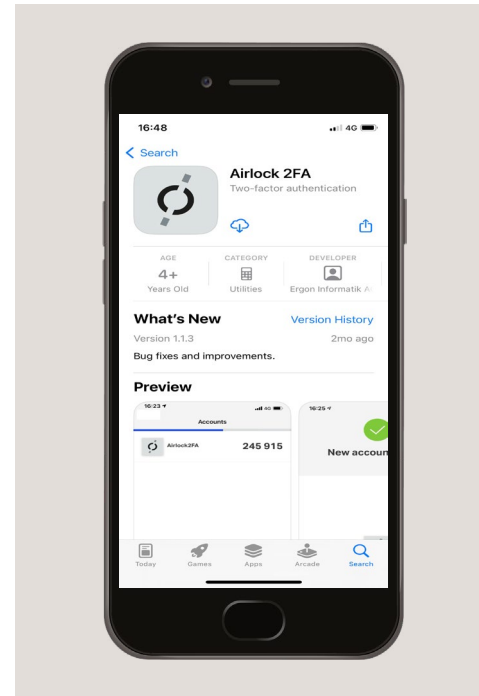
### Step 1b:

Search for Airlock 2FA in the store.



### Step 1c:

Download the Airlock 2FA app. You may need to enter your Apple or Google Play password.



### Step 1d:

Once downloaded, you will find the Airlock 2FA app on your device (you may need to swipe to locate it).



# Step 2: Log in to eAccess

## Log in to eAccess using your PC, iPad or Tablet

### Step 2a:

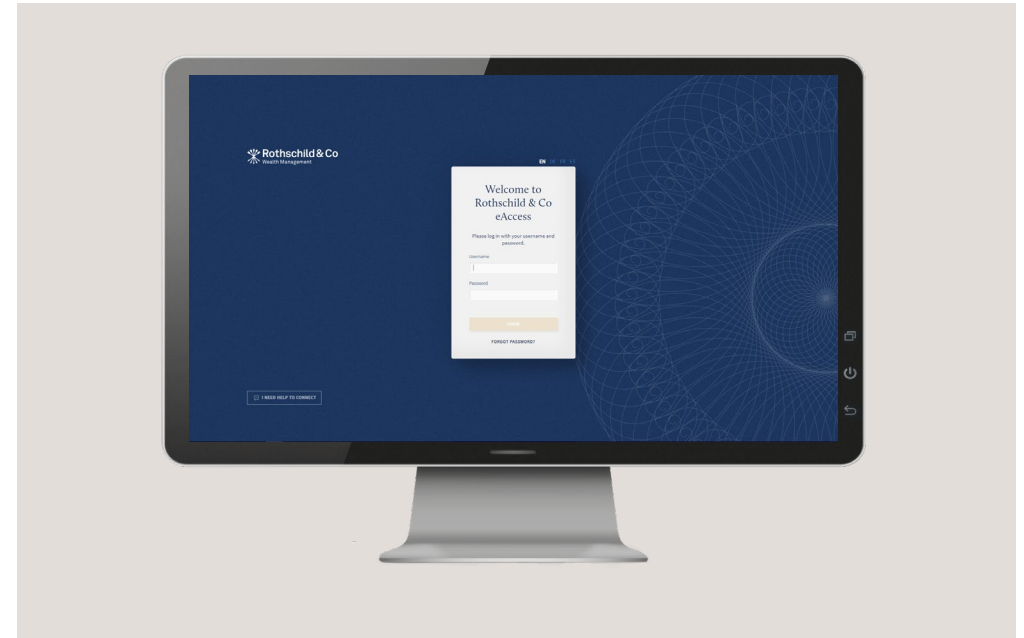
On your PC, iPad or Tablet, access your “**Welcome to eAccess**” email and click on the registration link or enter **<https://eaccess.wm.ch.rothschildandco.com>** into your internet browser address bar.

*Alternatively, if your custodian bank is not Rothschild & Co Bank AG, please enter **<https://eaccess.wm.de.rothschildandco.com>***

### Step 2b:

Once you click on the link, you will see the Rothschild & Co eAccess log in page.

Input your username and temporary password from your welcome email or password letter to continue.



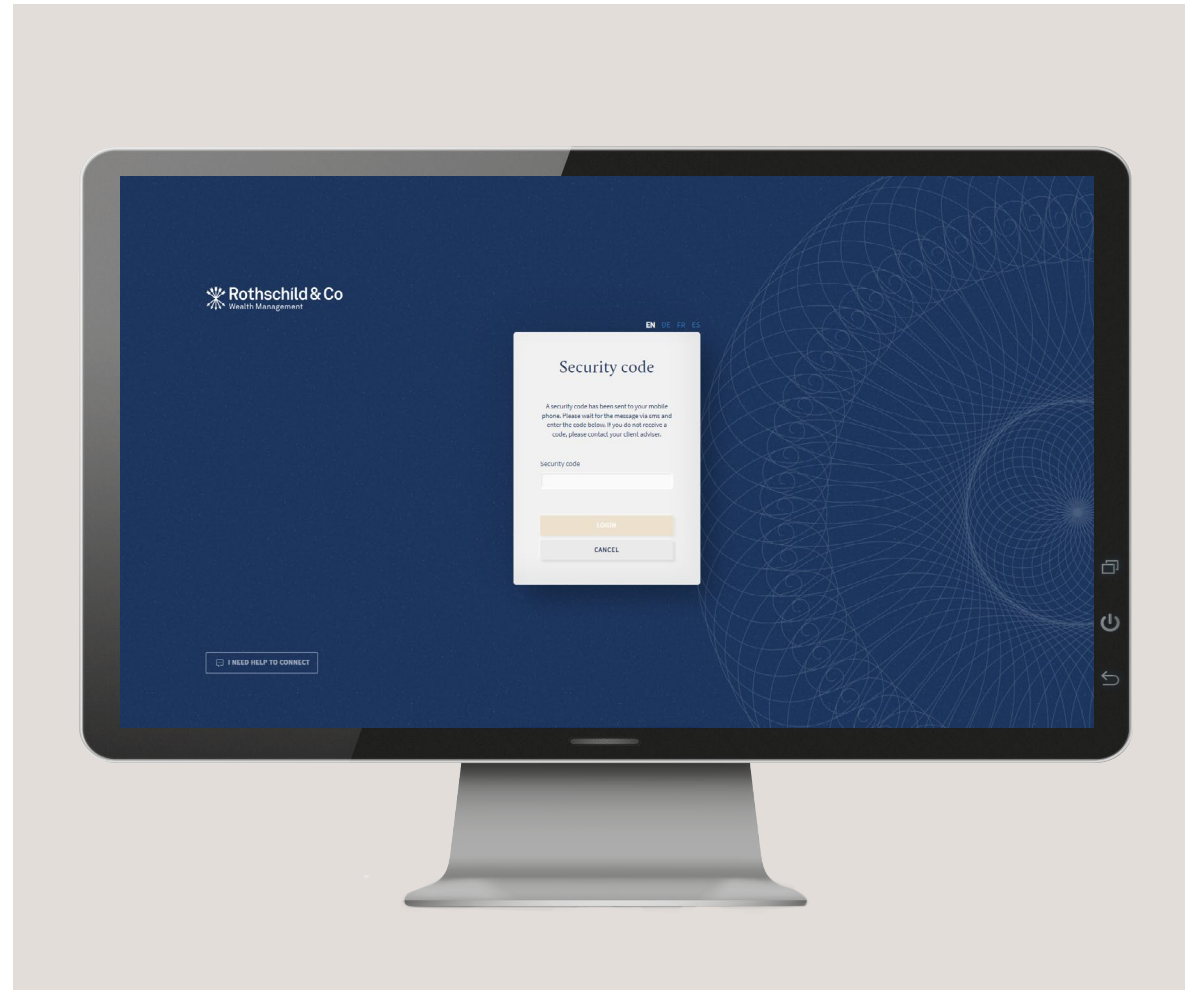
## Step 3: Verify your identity via SMS

### Step 3:

Once you have entered your username and temporary password, you will be sent an SMS passcode to the mobile phone number you provided when you requested your eAccess account.

If you do not receive this passcode, please get in contact with your client adviser.

If you have opted out to receiving a SMS passcode, please refer to the instructions on your activation letter.



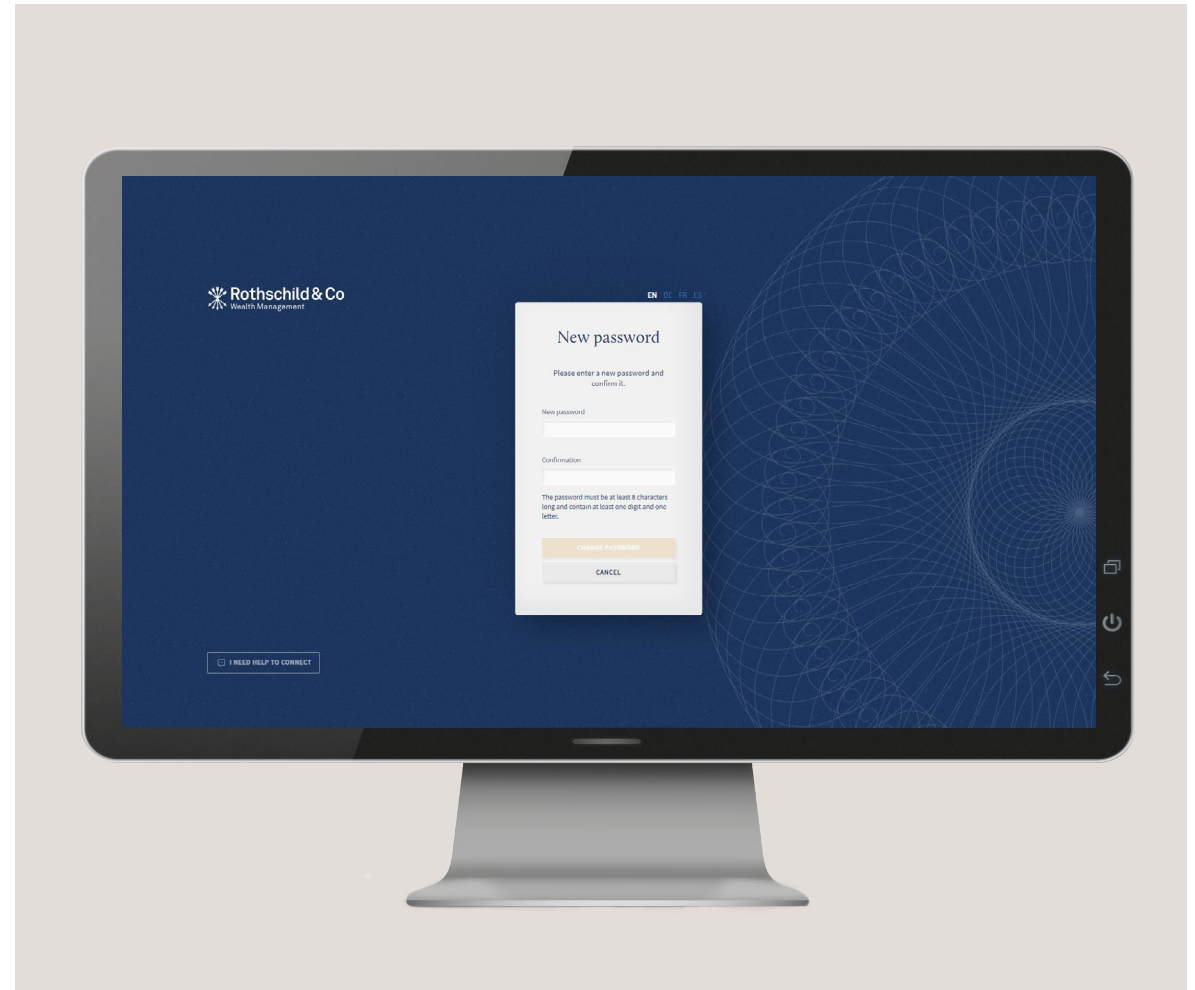


## Step 4: Set your password

Once you have verified the passcode, you will need to set your password.

Your new password must at least be 8 characters long and contain at least one digit and one letter.

# Step 5: Scanning the QR Code

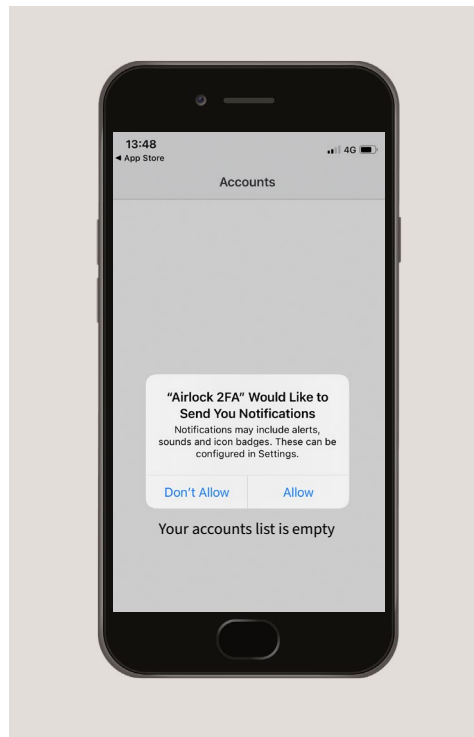
## Step 5a:

Once you have set your password, you will be shown an image onscreen on your PC. This is the QR code which you will need to scan using the Airlock 2FA app on your smart device.



## Step 5b:

When you open the Airlock 2FA app, you will be asked to allow the app to send you notifications.

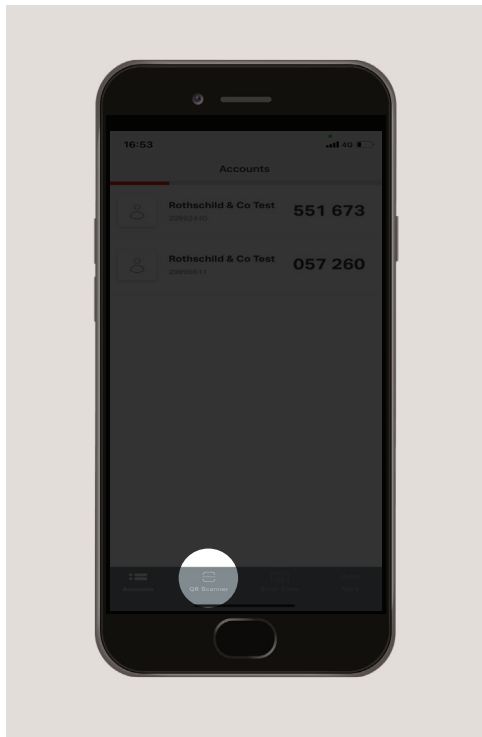

# Step 5: Scanning the QR Code (cont.)

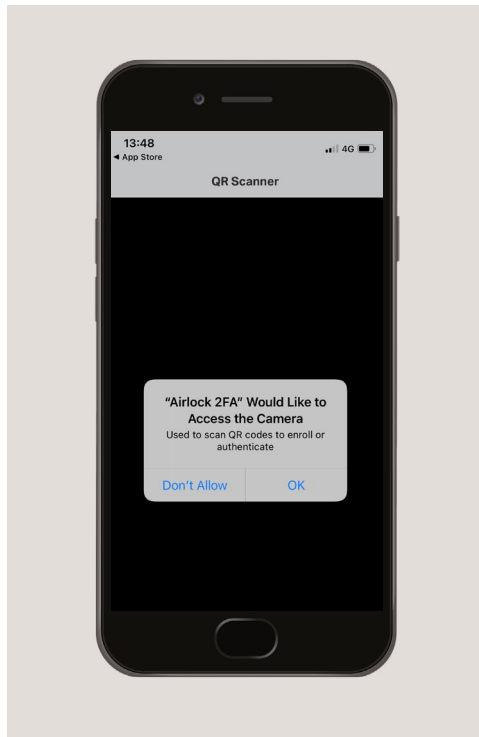
## Step 5c:

Select **“QR Scanner”** on the bottom of your smart device screen.



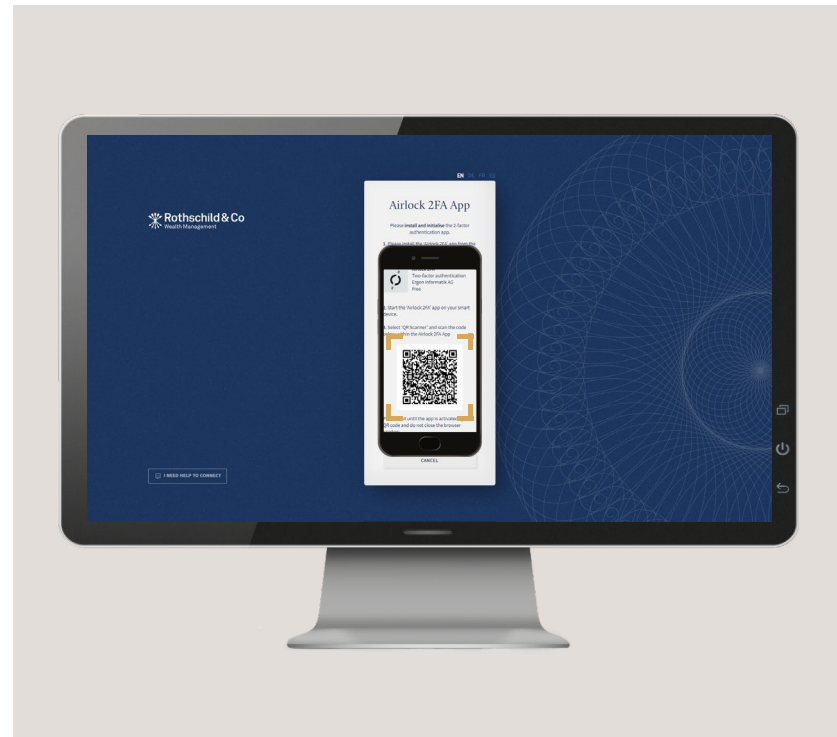
## Step 5d:

After selecting the **‘QR Scanner’**, you will be asked to allow the app to access your camera. Select **‘OK’**.



## Step 5e:

Using the **“QR scanner”** in the Airlock 2FA app, hold your smart device up to scan the QR code shown on the screen of your PC.

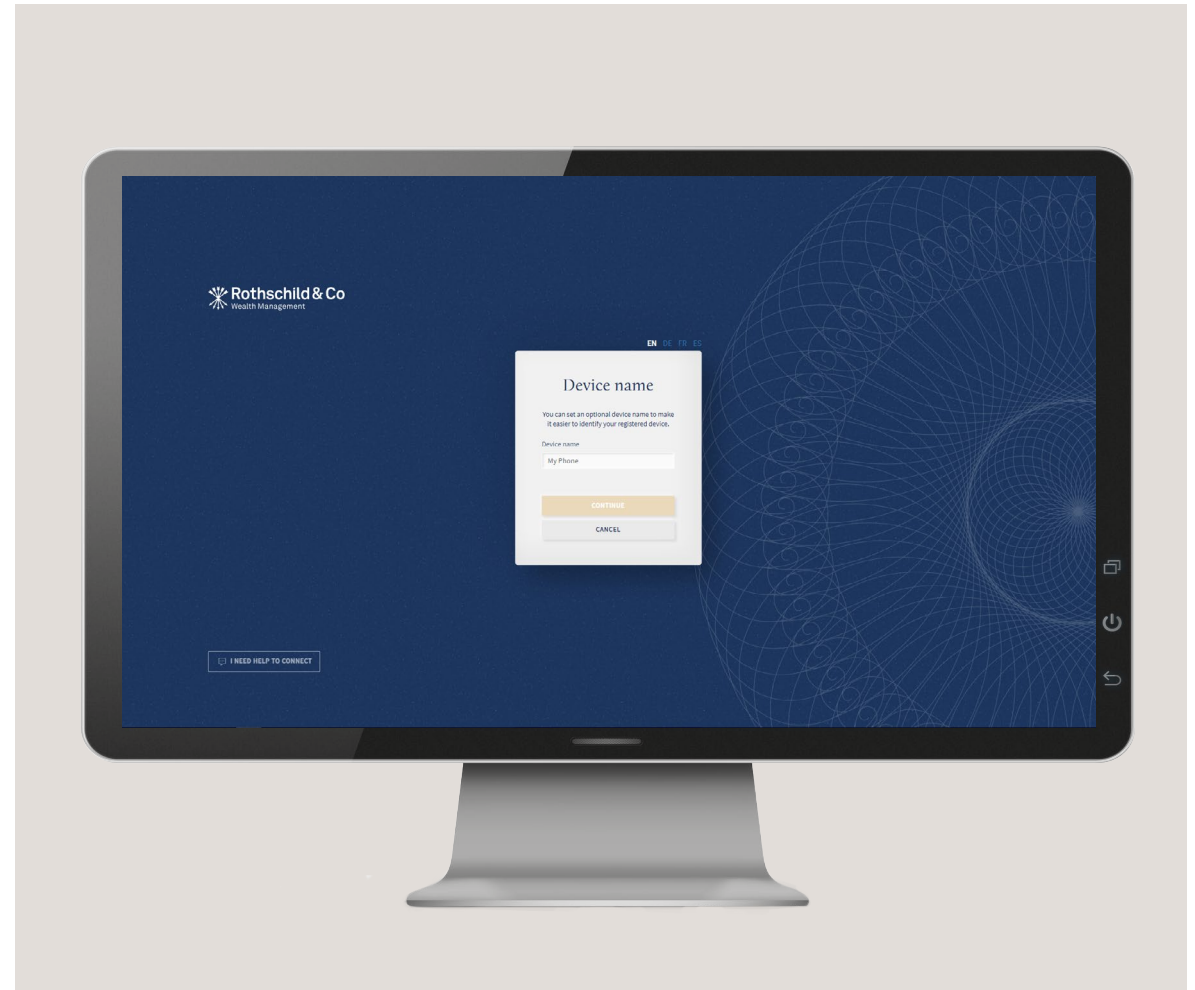

Once the QR code has been successfully scanned, the page will refresh and you will be asked to set an optional name for your smart device.

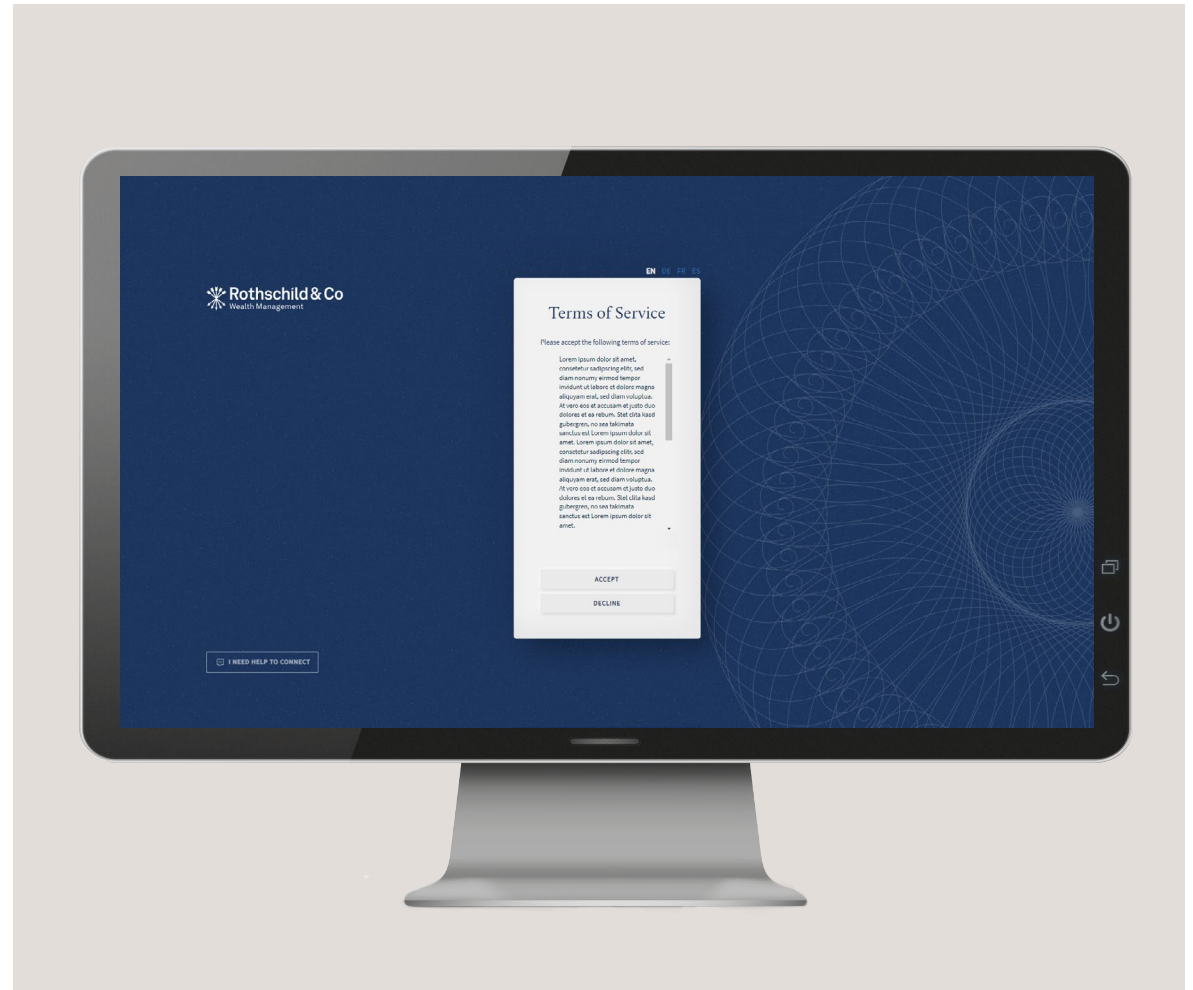


## Step 7: Agreeing to the Terms of Service

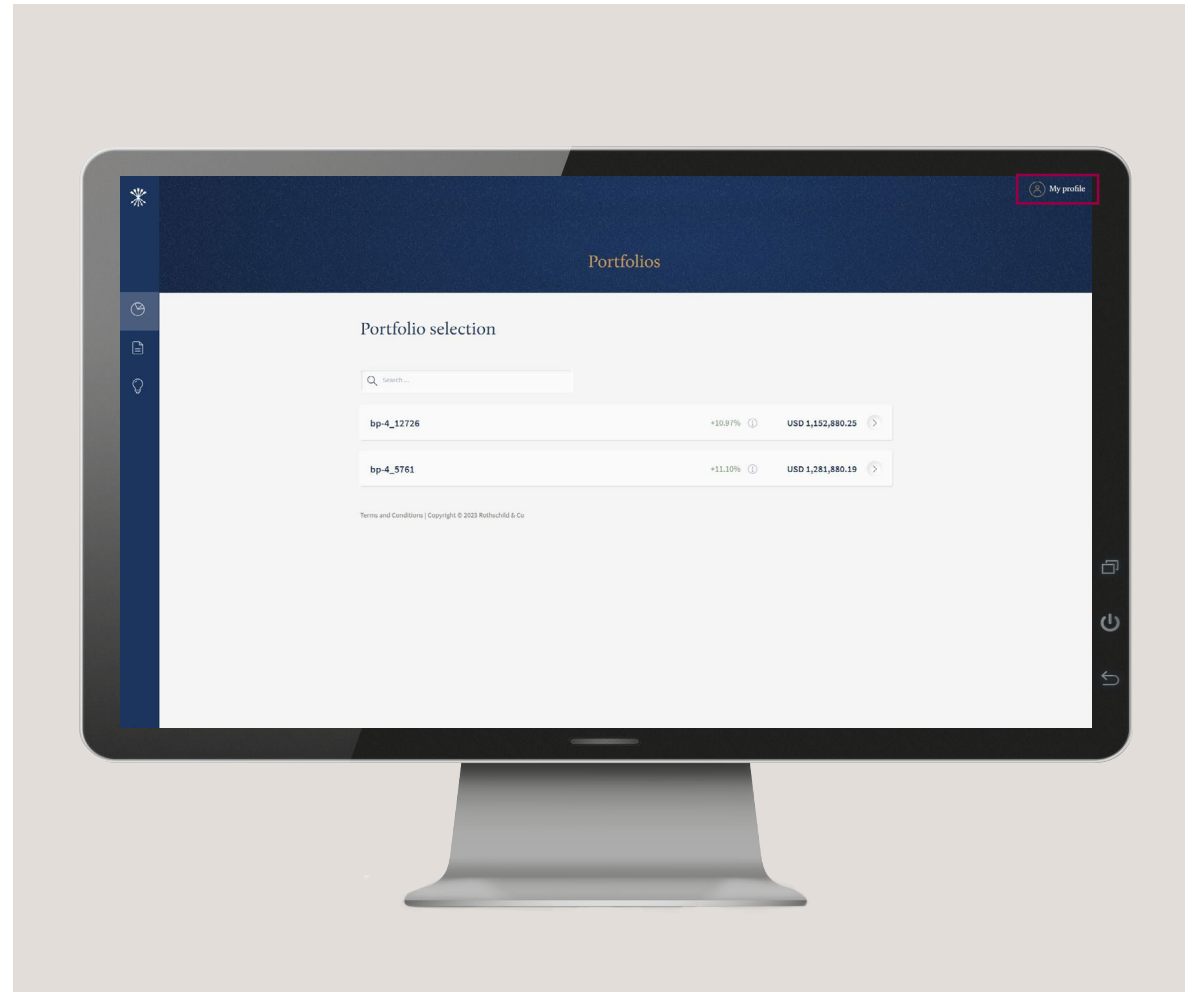

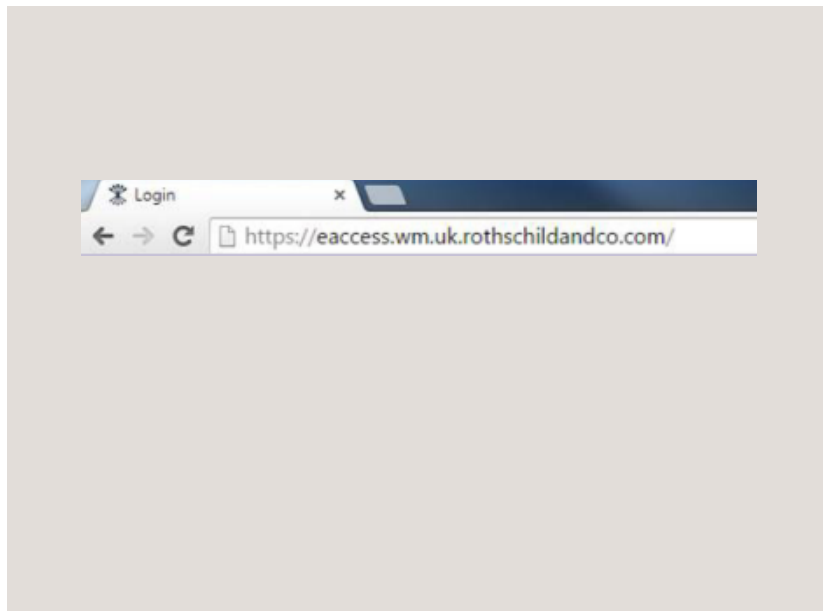

## Step 1a:

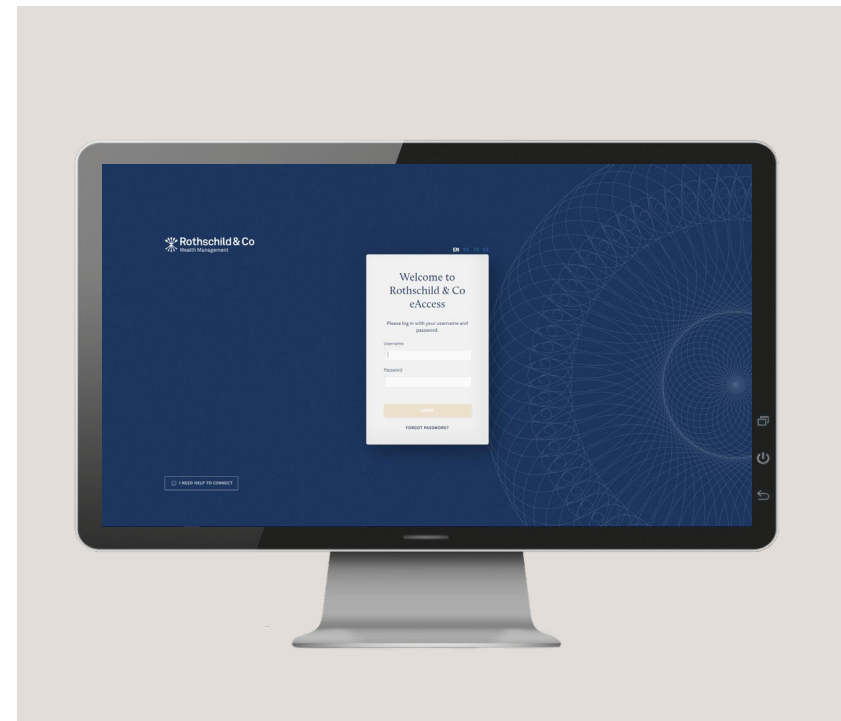
On your PC, iPad or Tablet,

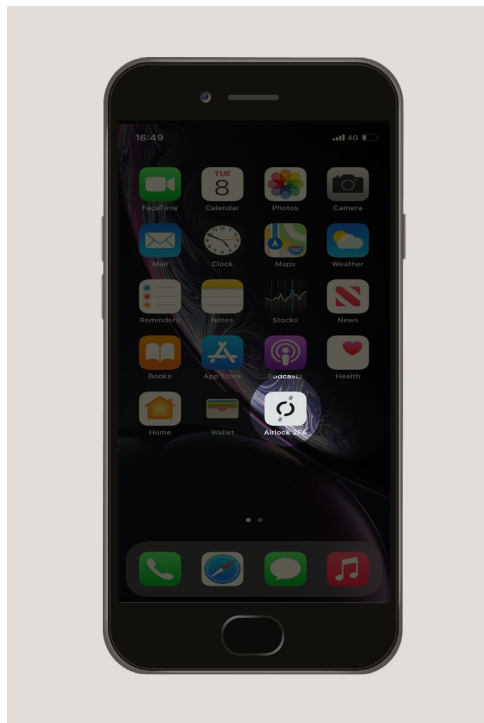

## Step 2: Approve via the Airlock 2FA app

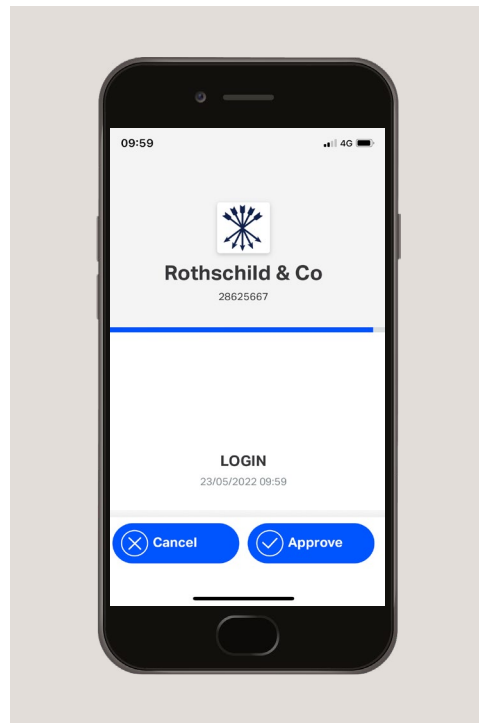
### Step 2a:

When successful, you will receive a notification from the Airlock 2FA app on your smart device.



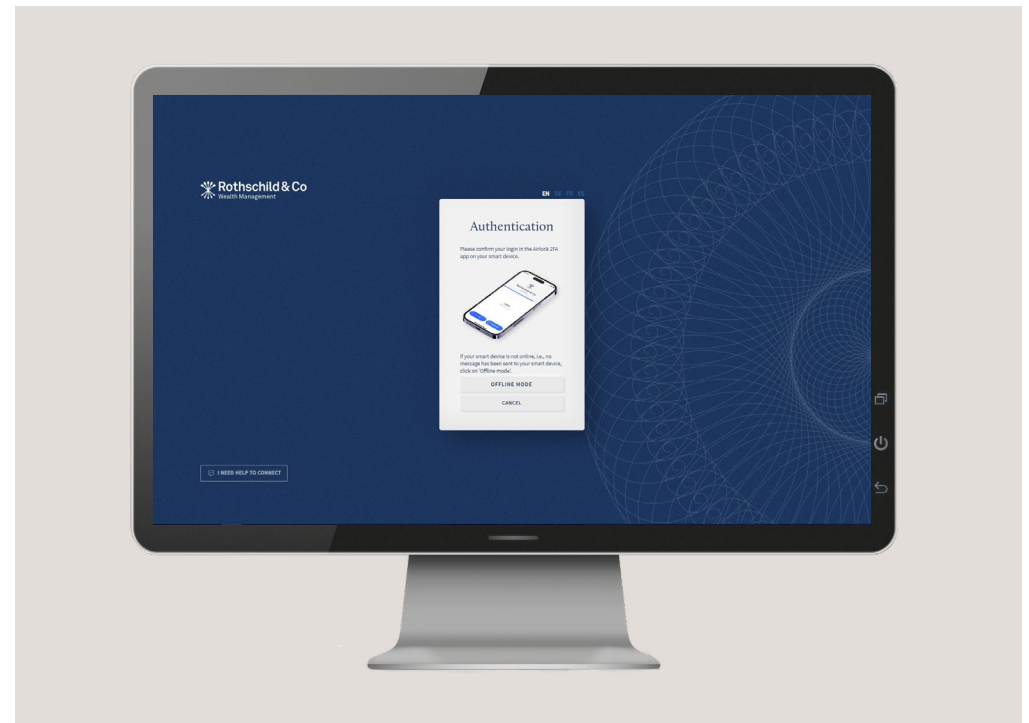
### Step 2b:

You can accept this by clicking on the approve button which will use your device's security to authenticate (e.g. Face ID).



### Step 2c:

If no notification arrives on your smart device then select '**offline mode**' on your PC and open the Airlock 2FA app on your smart device.

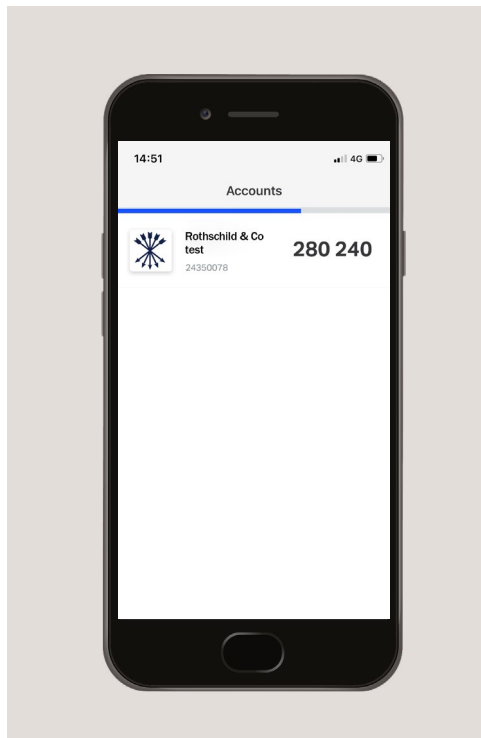

## Step 2: Approve via the Airlock 2FA app (cont.)

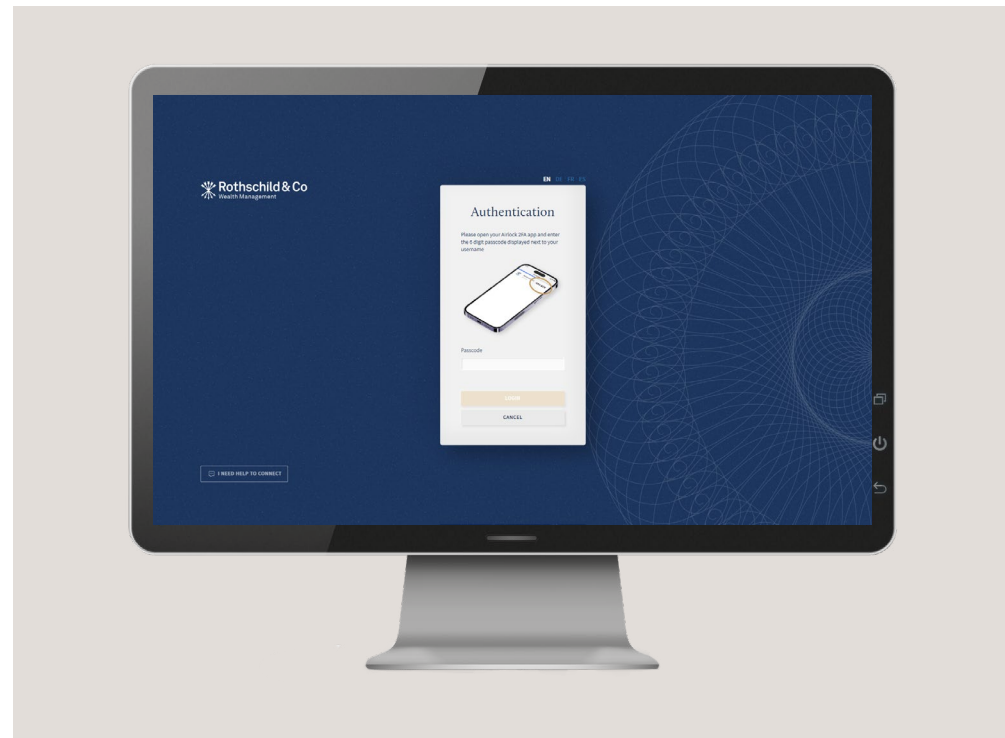
### Step 2d:

The Airlock 2FA app will display a 6 digit code next to your eAccess account name.



### Step 2e:

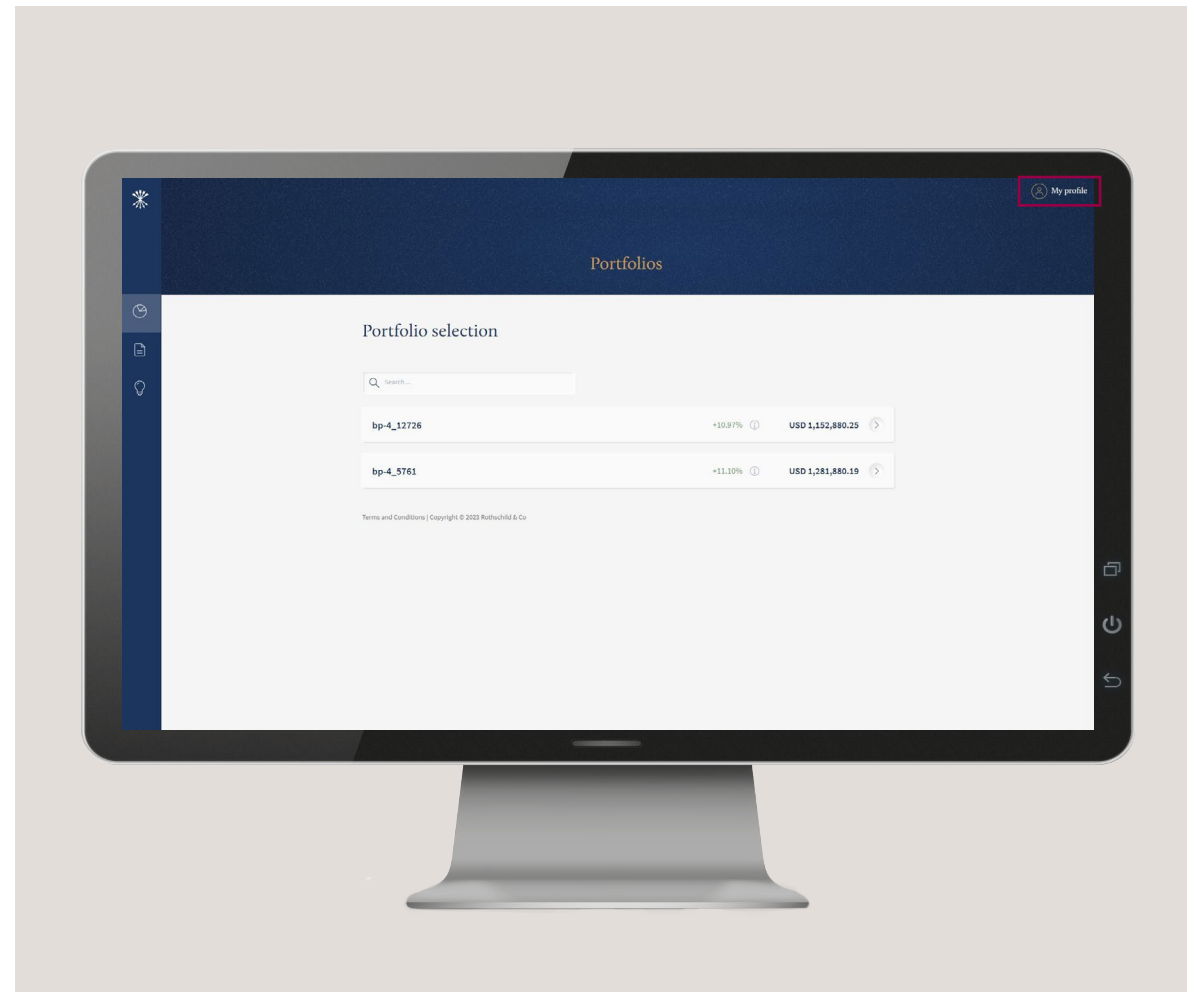
Enter the 6 digit code from the app on the PC screen.

## Step 1: Downloading the Airlock 2FA App

### To register a new device for eAccess you will need four things:

If you no longer have access to your existing device, please contact your client adviser and request that they remove it from your account. Once your client adviser has removed your existing device, you will then be sent a new registration email to reset your password and log in with a new device.

#### Item 1:

Your original activated device.

#### Item 2:

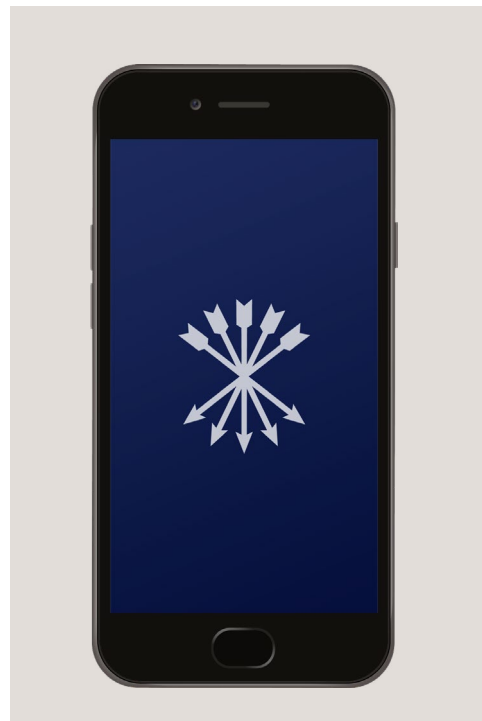
Your new device with "**the Airlock 2FA app**" downloaded.

#### Item 3:

A personal computer (PC), iPad or Tablet.

#### Item 4:

Internet access for both your mobile device and PC.

To activate a new device, login at <https://eaccess.wm.ch.rothschildandco.com> using your existing device.

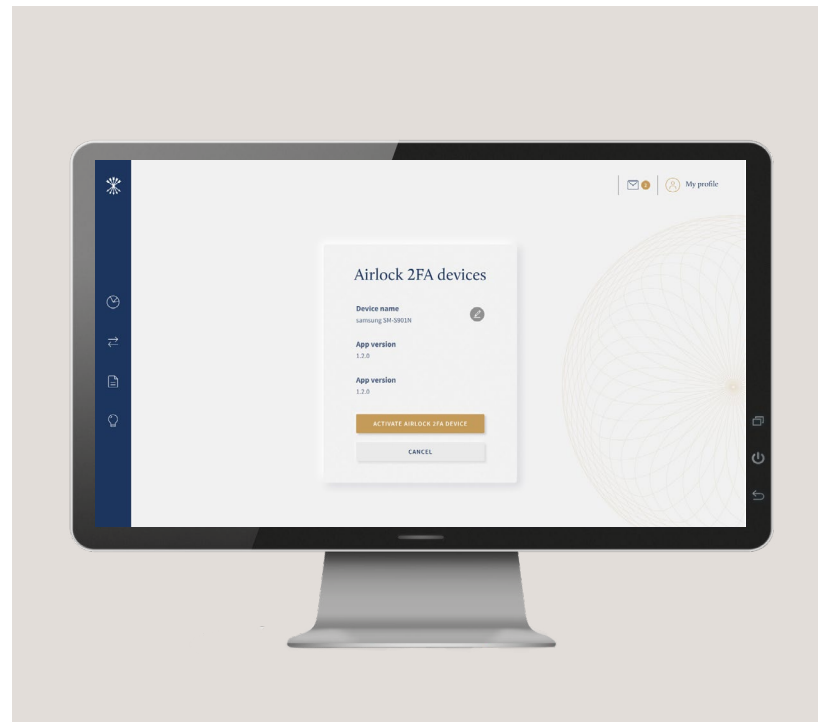
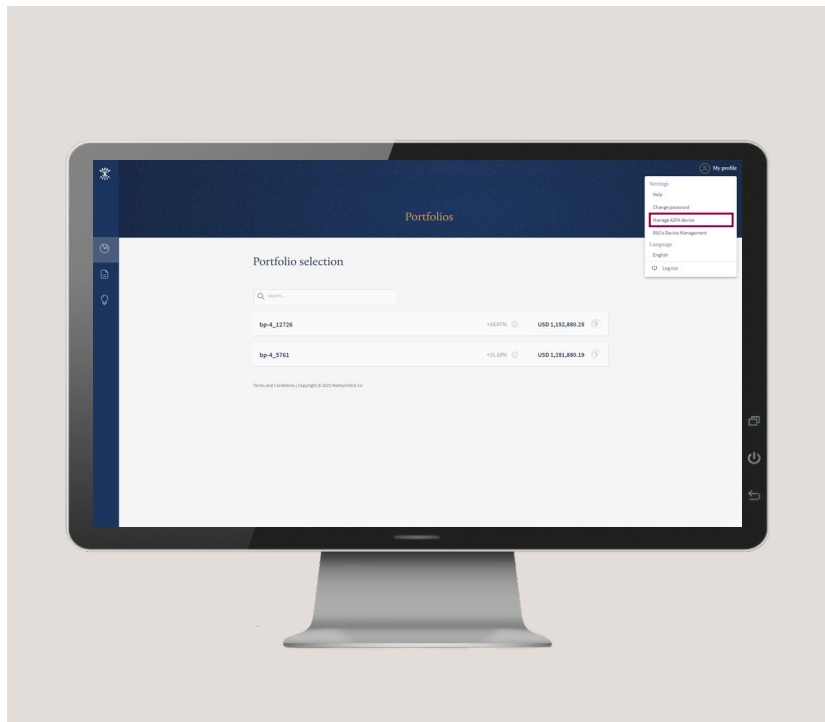

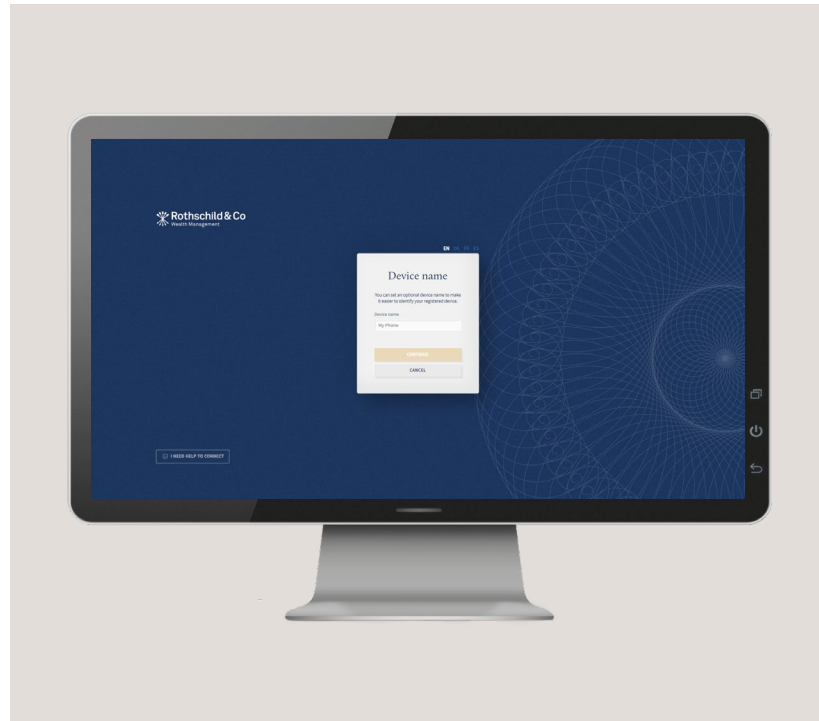
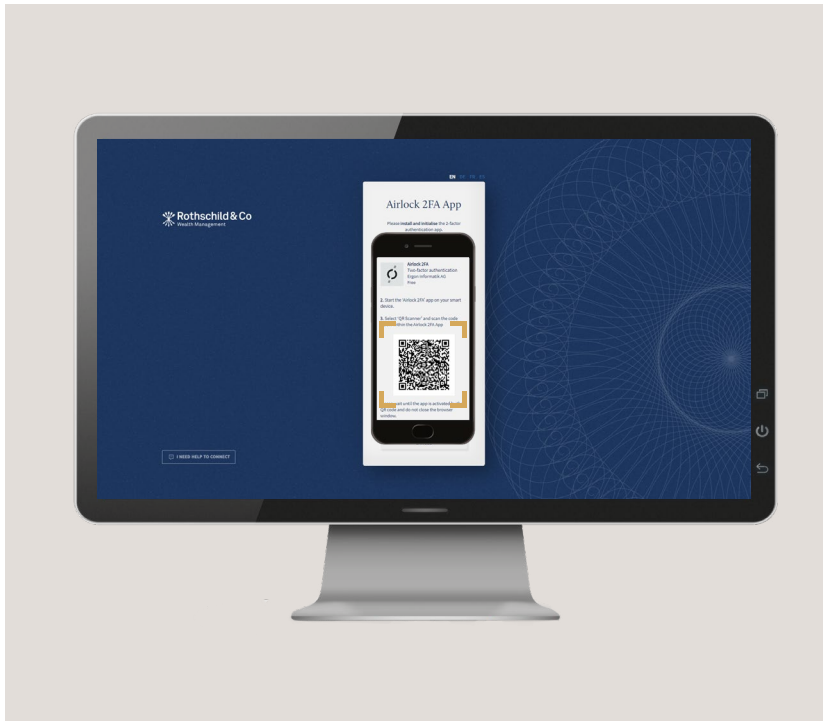
## Step 1c:

With your new smart device, open the Airlock 2FA app and select **QR Scanner** on the bottom of your smart device screen.

Using the QR Scanner in the Airlock 2FA app, hold your device up to scan the onscreen QR code.
